Bursary grant / academic extras

The Licensed Trade Charity awards bursaries for children to attend our independent, non-selective LVS Ascot school. You can apply for a bursary for your child if you have worked in the licenced drinks trade for 5 years or longer and your child has academic or other needs that are not being met by their current school. We can award day or boarding places for your child if needed. All applications are means tested and you can find our more here ([include relevant link](#)).

Apart from a bursary which pays school fees, the Licensed Trade Charity can also help with the following:

For children whose parents or guardians are on a very low income and or in receipt of benefits

- Visits as part of the curriculum to theatres, museums, art galleries
- Compulsory field school trips and Duke of Edinburgh Award expeditions
- Full Boarders Allowance – an allowance of £200 per pupil per term will be granted. It is available for a variety of items including transport costs, pocket money, school trips, and school uniform not within the standard uniform allowance

It is up to the pupil and parent to decide how this allowance should be spent and the monies will be directly paid to the supplier of the goods or LVS Ascot School

Any items or trips that are above this amount may have to be covered by parents or guardians unless there is extreme financial hardship

- Taxis/Public transport costs for medical / unusual home journeys for emergencies only
- Uniform including standard compulsory uniform, house shirts, obligatory sports uniform, school bags. An allowance of £350 per pupil has been made for this. Any uniform above this amount may have to be covered by parents or guardians unless there is extreme financial hardship

The following extras may be included subject to approval of the Director of Education / Principal of LVS Ascot

- Learning Support when agreed, assessed, and authorised by a senior member of LVS Ascot staff

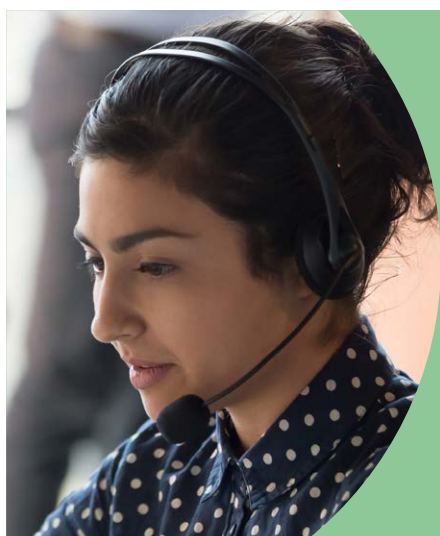
The following extras are to be paid by parents or guardians

- School, house and class photographs
- Taxis, other than for reasons detailed above
- All other optional co-curricular activities including but not limited to: Ballet lessons; Golf; Rowing; Polo etc

If, however, a bursary student excels in a sporting, artistic or academic activity, which requires extra funding, the school could be approached to consider the request to support the pupil. This would be as a potential scholarship student application.

For parents that contribute towards school fees an assessment will be done during the bursary application to take into account the costs for covering things like school transport, uniform, compulsory trips etc.

We hope this list will help you when deciding whether you would like to apply for a bursary for your child.
